Your information is stored securely and only accessed by appropriate individuals within ASSL. We will keep your information only for as long as is reasonably necessary for the purposes set out in this privacy notice and to fulfil our legal and regulatory obligations

For email enquiries we will keep your information for one year after the enquiry has been resolved, after which it will be deleted from our systems

9 Your data protection rights

- Right to erasure you can ask us to erase your personal information, in certain circumstances

- Right to object to processing you can object to the processing of your personal data, in certain circumstances
